*Please be aware that if payment is not received by March 1<sup>st</sup>, you will forfeit your right to a slip and the slip will be offered to those Club members on the Wait List.*

\* Should a slip renter choose not to renew his/her slip rental after the first season (s)he rents a slip, the following refund schedule for the Initiation Fee will be used depending upon the total initiation fee collected in the first and second (final) installments. Monies will be refunded as follows:

- < after one season, 50% of the total initiation fee billed will be refunded.
- < after two seasons, 30% of the total initiation fee billed will be refunded.
- < after three seasons, 15% of the total initiation fee will be refunded.
- < after four seasons no refunds will be made.

Members are encouraged to make periodic inspections of their own docks, mooring equipment and storage areas and to obtain their own hull insurance coverage if deemed advisable.
